Your donations meant life-saving equipment was available for Mr. Ladson


After seeing Dr. Fitzpatrick, an extensivist who works with patients from the Greer Transitions Clinic, Mr. Ladson learned he needed a CPAP machine as soon as possible to help treat his obstructive sleep apnea. This ailment put him at an increased risk for a stroke or heart attack which could have ended in right-side hemiparesis, or even death.

Mr. Ladson began trying to save money and raise funds to purchase the machine, but he still didn't have enough to purchase this expensive piece of equipment. Thanks to donors like you, Mr. Ladson was given a CPAP machine by the Greer Transitions Clinic. Your donations to the clinic ensure patients have access to life-saving treatments and medication when they need it most.

"Had Mr. Ladson not been able to see Dr. Fitzpatrick in an hour-long appointment, it could have taken months to diagnose him," said Amanda Biondi, Greer Transitions Clinic program manager. "Dr. Fitzpatrick is able to offer hour-long appointments, unlike traditional primary care, because the Greer Transitions Clinic is funded by philanthropy and is not a revenue-based system. Philanthropy is the reason that Mr. Ladson's life was saved."

"I'm so happy and thankful I got the CPAP machine," said Mr. Ladson. "My anxiety has decreased because I know my blood pressure and heart rate are going to improve."

The Cancer Patients Whose Lives You Touched

- A patient found herself in an unsafe living situation shortly after her breast cancer diagnosis. She became homeless and started sleeping in her car. Thanks to your support, we were able to provide her with gas cards and two weeks of stable lodging during her radiation treatment. Our nurse navigation team, which is also funded by your philanthropic support, connected her to a community homeless program to sustain her lodging situation and to get her on a waitlist for income-based housing. Thanks to your support, she has been able to move forward with her potentially life-saving treatment.
- While a patient was going through daily radiation treatments for prostate cancer, his household income decreased by half and he was unable to pay his rent and car expenses. Between medical appointments, he continued to pursue his job search. While he was going through this incredibly difficult time, your donations helped him keep the lights on, put gas in his car to get to his appointments, and put food on the table for his family. "Thank you for helping me at a time when my physical and emotional health were being challenged to the core," he said. Our nurse navigation team continues to work with this patient, connecting him with necessary resources and providing emotional support.
- A patient diagnosed with head and neck cancer needed financial support to pay his electrical bill. Your support helped keep his lights on while going through treatment. Our head and neck nurse navigator, funded by philanthropy, worked closely with this patient and assisted him with disability program assistance. The navigator also connected him with a registered dietician who was able to educate him on tube feeding. Because of your generosity, this patient had an incredible navigation team providing various types of support throughout a very difficult time in his life.



You helped Charon advance her nursing career without putting a financial strain on her family

"I'm so thankful for the nursing scholarship program through the Roper St. Francis Foundation. It has allowed me to work toward my MSN without placing a huge financial burden on my family," said Charon Manigault, Clinical Nurse Manager of the Intensive Care Unit at Mount Pleasant Hospital.

Charon has been in this leadership role for almost three years, but she has been a nurse with Roper St. Francis Healthcare for the past 17 years. "I lead an amazing group of teammates who make a difference in the lives of every single patient they meet," said Charon. "We have endured the most trying years that healthcare has ever seen, becoming a COVID ICU for the system and continuing to provide excellent care for our adult population."

Enrolling in an MSN program right before the start of the pandemic was a difficult decision for Charon. She thought about returning to school but was unsure of how that choice would affect her family. As a divorced mother of three (an adult, a soon-to-be college graduate, and a high school junior), the financial burden of starting school was a big concern for her. However, she knew completing her MSN would allow her to obtain a deeper knowledge of healthcare in this changing environment, which would in turn make her a stronger resource for her team and enhance her leadership skills.

"This scholarship has given me the ability to move forward with my education without a huge financial strain on my family. Thank you for your generosity and for supporting this scholarship for nurses at Roper St. Francis Healthcare."

Thanks to you, 37 nurses were able to advance their education through scholarships in 2021.

You are helping patients like Hermin get back to doing what they love

Recreational therapy is an adjunct type of therapy that focuses on helping patients transition back into their daily lives and communities after a physically-altering event. These activities may take patients to their workplace, to walk their dog, to a park, or for some, like Hermin, to participate in the wheelchair division of the Cooper River Bridge Run.

Hermin Garic, originally from Bosnia, became paralyzed as a very young child during the Bosnian War when his village was attacked and he was struck by shrapnel from a grenade. Six years later he arrived with his father in the United States. This was where he discovered his love for adaptive sports. Hermin officially started racing in 2004 and now is a full-time competitor, with multiple Cooper River Bridge Run first-place finishes under his belt.


For the past 25 years, Roper St. Francis has had a bus available to take patients - predominantly stroke, spinal cord and brain injury patients - out to participate in therapeutic activities. However, through the pandemic, this program was put on pause and the vehicle that was being utilized had declined to the point of disrepair. It was no longer safe for patient use. Due to the unrepairable vehicle, the program was put on pause.

Thanks to your generous support, we are purchasing a brand-new van complete with an ADA-approved wheelchair lift with interior features to provide safe transport for patients like Hermin.



"I have always prided myself as being as independent as possible and this was only achieved through hard work during the countless hours I spent in physical and occupational therapy," said Garic. "Individuals have to realize that rehab is one of the major keys in gaining control of your life again. This includes getting involved in community activities like adaptive sports, which for me, was the perfect antidepressant to help me see my life in a new light."

Thank you for allowing us to resume these essential components of therapy for our patients.



You helped Mr. Thompson find his family in his final days

Mr. Thompson* was admitted to the Roper Hospice Cottage in August of 2021 after a squamous cell cancer diagnosis on the side of his neck. He was a homeless gentleman whose cousin has taken him into her care until his needs became more than she was able to accommodate.

While in hospice care, the team at the Roper Hospice Cottage became Mr. Thompson's family. He had a very swollen neck from the tumor that affected his hearing, ability to speak and ability to turn his head, but his hospice family quickly learned how to work around these obstacles and found ways to bring him joy in his final days. They assisted him every day in eating for pleasure and they developed a daily routine that he loved. Each morning the staff helped him get dressed, into his wheelchair and outside for his morning coffee. "We were able to assist him with the dignity that he deserved," said a Roper Hospice teammate.

Mr. Thompson developed a close relationship with the chaplain and Master of Social Work, in addition to all of his caregivers. When he arrived to hospice, he was a previously homeless man with very few family and friends. At the time of his death in November, he was surrounded by his entire hospice family and his cousin, all holding his hands as he peacefully passed.

Philanthropic support was used to help cover Mr. Thompson's time at the Roper Hospice Cottage as well as his cremation. Thanks to you, Mr. Thompson was able to spend the final months of his life surrounded by love and his newfound family.

Thanks to you, Ms. Maitland was brought back to life

Ms. Maitland was admitted to the hospital with heart failure exacerbation and she had an echo that showed worsening left ventricular function, as well as worsening mitral regurgitation. In other words, her heart was rapidly failing. "I was really out of it," said Ms. Maitland. "You name it, I had it – shortness of breath, no appetite – I couldn't even walk around the house to do what I needed to do. I was half dead really."

She was referred to the Roper Heart Center and immediately began working with Kelly Guerrero, a physician assistant in the valve clinic. From here, everything happened very quickly, Ms. Maitland recalls. This speed is due largely in part to the coordinating role that Kelly plays; coordinating testing and physician visits to minimize the time from diagnosis to treatment.

It was determined that Ms. Maitland would greatly benefit from MitraClip, a minimally invasive way to repair the mitral valve for patients that are not candidates to have surgery. It is typically a quick procedure and most patients are able to go home the following day. Patients who have this procedure can have improved quality of life, less symptoms and fewer admissions to the hospital with heart failure.

"When I came to Roper, they did everything so fast," said Ms. Maitland. "I am really feeling great now. I couldn't get around, but now I can do everything. I may not be able to run a marathon, but I'll sure give it a good try!"

Thanks to your support, we are able to hire teammates like Kelly who help to not only expedite care for our patients, but also streamline the process to make it as easy for the patient as possible, by reducing multiple visits and other factors that may ultimately delay their care.



"In patients with mitral valve disease, we have learned that the longer you wait, the worse the outcomes," said Kelly. Upon my hire, our goal was to get patients seen in a more timely manner so they could ultimately get the procedure needed sooner. I think we were able to do that very well with Ms. Maitland. We were able to see her, schedule all necessary testing and get her mitral valve repaired in under six weeks – which is pretty amazing!"

Kelly also spends time seeing patients in clinic, working with the valve team, coordinating weekly interdisciplinary meetings and checking in on patients after their procedures to ensure they are maintaining optimal health at home.

"My experience working with the heart and vascular team was just beautiful," said Ms. Maitland. "They got right in there and did just what they needed to do. They brought me back to life."

Grants Spotlight

A record \$7.9 million in government (\$6.86 million) and non-profit (\$1.04 million) grants were awarded in 2021 for projects ranging from pandemic recovery to improving birth outcomes. Support for Covid-19 recovery efforts was significant—more than \$3.6 million from federal and state agencies—and FEMA provided an additional \$1.6 million to close out Roper Hospital's disaster mitigation projects.

A new \$25,000 State Opioid Reduction award allowed the Opioid Reduction Task Force to engage nationally recognized experts to develop

a plan for implementing Medication Assisted Treatment in the EDs, resulting in a pilot program featured by the SC Behavioral Health Coalition.

A grant from the Bon Secours Mercy Health Foundation helped women's services launch Centering Pregnancy, a best-practice program focused on group pre-natal care to improve birth outcomes, at two of our Ob/Gyn practices.

Other notable projects funded by nonprofit foundation included the Greer Transitions Clinic, the Healthy People Healthy Carolinas coalition and AccessHealth Tri-county Network's diabetes prevention and management services for underserved patients.



Bon Secours Mercy Health Foundation Grant Helps to Launch Centering Pregnancy

For more than five years, Dr. Eleanor Oakman and her colleagues at Roper St. Francis have sought a better approach to prenatal care.

By providing access to innovative, patient-centered care, Ob/Gyn practitioners can help reduce infant and maternal morbidity and mortality rates and improve long-term health outcomes for mother and baby. Preventing preterm and low birth weight deliveries lowers the risks for life-threatening health problems and developmental delays.

In 2021, Dr. Oakman, Director of Women's Services for Roper St. Francis Physician Partners, partnered with nursing leader Laura MacMillan, Director of Women's Services, to initiate Centering Pregnancy at Roper St. Francis with support from a \$69,100 grant funded by the Mission Outreach Program at Bon Secours Mercy Foundation.

"Centering provides a space for women to feel listened to, supported and empowered," said Dr. Oakman at the program's official launch in February 2022 at Bon Secours St. Francis. "By spending more time with patients in a non-threatening and engaging setting, we feel that we can improve prenatal term rates and breast-feeding rates for our patients."

A Centering Pregnancy steering committee of 15 teammates including Physician Partners leadership, providers and staff as well as teammates from marketing and coding came together to establish the program infrastructure. Implementing the program during Covid was challenging at times, with experts at Centering Health having to provide training and guide the process through Zoom instead of on-site. Committee members felt that Centering's multidisciplinary model provides a strong foundation for the new program by including administrative support staff in adopting a new clinical approach to prenatal care.

Over the 12 months of the grant, the team was able to establish the program by:

- Contracting with Centering Health Institute
- Onboarding a program facilitator
- Establishing training modules, and
- Creating two quiet and calming physical spaces for group sessions.

Ob/Gyn physician Dr. Joyce Noriega will be leading a Spanish language group and emphasized the importance of being able to spend more time with patients in the group setting. Dr. Noriega, who has previous experience with the Centering model, described how a lonely, depressed patient going through pregnancy on her own was transformed by getting to know the other women in her group and helping each other out, finding transportation, providing childcare and sharing text chains.

Erin Kendall, midwife and program facilitator, has fully embraced the program. "I talked to several other Centering Pregnancy places and they were really impressed with how warm and welcoming our space is," said Kendall, surrounded by roomy rocking chairs and brightly colored walls. "We are excited to begin this rare and beautiful program that makes patients happy, makes providers happier and provides better outcomes."

With the infrastructure in place and public launch completed, the Centering Pregnancy team is busy recruiting the first group session to start March 23. They are now on the road to receiving Centering certification (a two-year process) from the nationally recognized Centering Healthcare Institute for two practices, one based at Bon Secours St. Francis, the other at Roper St. Francis Berkeley.



What is Centering Pregnancy?

The innovative Centering approach is based on establishing three essential elements for providing patient care—health assessment, interactive learning and community building—during a billable healthcare visit provided in a warm group setting. With Centering Pregnancy, 8 to 10 women at roughly the same gestational stage receive prenatal care through 10 Centering group sessions. At each session, each mother-to-be is individually assessed and learns to take her own vital statics before the group circles up to engage in a 90- to 120-minute educational session facilitated by their provider. Sessions are guided by engaging and detailed workbooks that cover topics specific to gestational age. Providers are able to spend more time with their patients and bring in specialists to address shared concerns expressed by the group—from doctor's visits to diapers to delivery.
